RESOLUTION NUMBER R- 274580  
ADOPTED ON OCT 16 1989

WHEREAS, the San Diego Scholarship Fund, Inc. was formed to administer a program of providing educational opportunities for needy students; and

WHEREAS, it is desired to establish a San Diego Scholarship Trust Fund to provide a vehicle for citizens to contribute money to the scholarship program in a tax-deductible manner and to establish a source of funds to defray all expenses incurred in the operation of the scholarship programs; and

WHEREAS, the funds will be used to pay such costs as may be associated with the education process, including tuition, books, and miscellaneous expenses; and

WHEREAS, as the funds are expected to be directed by the donor, Council Policies and Administrative Regulations dealing with procurement and other expenditures will be waived for all donations and expenditures of scholarship funds; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby authorized and directed to establish an interest bearing trust fund to be entitled "San Diego Scholarship Trust Fund" for the purpose of serving as a repository for funds donated to the City for scholarship program purposes.

BE IT FURTHER RESOLVED, that the President and Treasurer of San Diego Scholarship Fund, Inc. be and they are hereby designated as the administrators of said fund.

BE IT FURTHER RESOLVED, that Council Policies and Administrative Regulations dealing with procurement and other expenditures be and they are hereby waived for all donations and expenditures of scholarship funds.
