WHEREAS, Jim was assigned to the Patrol Division from October 1956 to July 1968; and

WHEREAS, Jim was promoted to Detective and assigned to the Burglary Division from August 1968 to June 1971; and

WHEREAS, Jim was transferred to the prestigious Homicide Division where he worked from July 1971 to June 1986; and

WHEREAS, in June 1986, Jim as assigned to Background Investigations where he remained until his retirement on October 31, 1989; and

WHEREAS, during his career with the San Diego Police Department, Jim received several Commanding Officer Citations for his investigative abilities and numerous safe driving awards; and

WHEREAS, Jim plans on spending his long deserved retirement travelling throughout the United States, perhaps even to Wichita, in his new motorhome; NOW, THEREFORE,


