and that additional funds necessary to settle Case No. 600717, W. M. Forys (Parcel 26); Case No. 600718, A. Forys (Parcel 27), and Case No. 600714, Perry (Parcel 15), be transferred from the Open Space General Bond Fund 79104 to the individual Goldfinch Canyon Open Space Project Fund.

THEREFORE, BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and is hereby authorized and empowered to settle the above-entitled actions with the payment of the following sums:

Said payments are for the acquisition of real property by the City of San Diego located in Albatross and Goldfinch Canyons pursuant to the Uptown Open Space Project which was authorized by City Council in Resolutions R-270416 and R-270419 adopted February 23, 1988.

BE IT FURTHER RESOLVED that the following sums have already been deposited with the County Treasurer in accordance with the eminent domain actions referred to above:

BE IT FURTHER RESOLVED that the additional funds required to settle Case No. 600709, <u>Hansen</u> (Parcel 4), in the amount of \$21,075.00 are available in the individual Albatross Canyon Open Space Project Fund.

BE IT FURTHER RESOLVED that the City Auditor and Controller is hereby authorized and empowered to transfer \$111,175.00 from the Open Space General Bond Fund 79104 to the individual Goldfinch Canyon Open Space Project Fund to cover the additional

funds required to settle Case No. 600717, <u>W. M. Forys</u> (Parcel 26), Case No. 600718, <u>A. Forys</u> (Parcel 27), and Case No. 600714, Perry (Parcel 15).

BE IT FURTHER RESOLVED that the expenditure of said amounts totalling the sum of \$304,750.00 is for the settlement of these eminent domain actions, including full payment for all parcels, costs and interest, and for all damages of every kind and nature suffered or to be suffered by reason of the acquisition of said parcels.
