RESOLUTION NUMBER R-274595

ADOPTED ON OCTOBER 17, 1989

WHEREAS, on October 17, 1989, the Council of The City of San Diego, considered the appeal of Margaret Palmer Gordon-Espe from the decision of the Planning Director in granting an early release from Single-Family Neighborhood Protection Ordinance No. O-17250, Case No. 89-3043, submitted by Richard Esposito, Applicant, for the property located at 1304 24th Street; and

WHEREAS, the property is located within the Golden Hill Community Plan area and is more specifically described as Lot 1, Vista de Oro, Map No. 11934, in the Subarea 1 zone; and

WHEREAS, the Planning Department recommended to release the subject property as the analysis of the neighborhood concluded that the area's character was multi-family; and

WHEREAS, the Greater Golden Hill Planning Committee reviewed the project and on September 13, 1989, recommended approval for an early release; and

WHEREAS, on July 5, 1989, after case review and public testimony, the Planning Director approved an early release request from the Single-Family Neighborhood Protection Ordinance; and

WHEREAS, subsequent to the decision of the Planning Director the City Clerk received several requests for appeals from the case decision from individuals alleging that protection from construction of additional dwelling units is required to prevent exacerbation of parking problems; and


WHEREAS, this appeal was set for public hearing on
