
WHEREAS, The City of San Diego proposed amendments to the Golden Hill Community to clarify language and reduce residential density recommendations west of 28th Street;

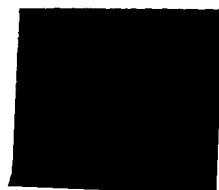
