ADOPTED ON OCT 17 1989

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to initiate and conduct a design/build competition for the proposed new Civic Center, and to expend an amount not to exceed \$693,000 for honoraria and for competition support expenses from Fund 41300, Org. 106, Acct. 4279, C.I.P. 37-220.0, all as more particularly described in that Manager's Report attached hereto and by this reference incorporated herein.

BE IT FURTHER RESOLVED, by the Council of The City of San Diego, that one-third or thirty percent of the slots for the semi-finalists shall be reserved for architectural design firms of fifteen persons or less.

BE IT FURTHER RESOLVED, by the Council of The City of San Diego, that said honoraria is contingent upon the sale of bonds in connection with the above-named project and shall be reimbursed from bond proceeds.
