



BE IT RESOLVED, by the Council of The City of San Diego that the low bid of ACACIA LANDSCAPE COMPANY, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE LANDSCAPE MAINTENANCE OF DESIGNATED CENTER MEDIANS, RIGHTS-OF-WAY AND OPEN SPACE WITHIN THE MIRA MESA LANDSCAPE MAINTENANCE DISTRICT as may be required for a period of one year, beginning December 1, 1989 through November 30, 1990, for a total estimated cost of \$63,400.00; terms net 30 days, with options to renew contract for four (4) additional one (1) year periods, with a price escalation each year not to exceed 10% above prices in effect at the end of each prior year.
