BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for QUINCE STREET PEDESTRIAN BRIDGE REHABILITATION, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on OCT 30 1989, and bearing official Document No. W.O. 119244, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for QUINCE STREET PEDESTRIAN BRIDGE REHABILITATION.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized, if circumstances warrant, to finance or refinance this project with tax exempt securities.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$94,000 within Capital Outlay Fund 30245 from CIP No. 29-600 OCEAN BEACH PIER - RECONSTRUCTION to CIP No. 53-047 QUINCE STREET BRIDGE.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$219,500 from Capital Outlay Fund 30245, CIP No. 53-047 QUINCE STREET BRIDGE, is hereby authorized solely and exclusively for said project and related cost, and authorizing the Auditor and Comptroller, upon advice from the administering Department, to transfer excess budgeted funds, if any, to the appropriate reserves.
