BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$91,610 from Fund 30245, CIP No. 61-002 ANNUAL ALLOCATION - NEW TRAFFIC SIGNALS, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to retain excess budgeted funds, if any, in CIP No. 61-002 ANNUAL ALLOCATION - NEW TRAFFIC SIGNALS.
