BE IT RESOLVED, by the Council of the City of San Diego that Resolution No. 274109, adopted on July 31, 1989 is hereby rescinded.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for POINT LOMA AVENUE BEACH ACCESS STAIRWAY AND RECONSTRUCTION OF OCEAN WALKWAY SOUTHERLY OF SANTA CRUZ AVENUE, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on OCT 30 1989, and bearing official Document No. W.O. 119024, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for POINT LOMA AVENUE BEACH ACCESS STAIRWAY AND RECONSTRUCTION OF OCEAN WALKWAY SOUTHERLY OF SANTA CRUZ AVENUE.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized, if circumstances warrant, to finance or refinance this project with tax exempt securities.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$5,000 from the Deposit Trust Fund 63021 to Fund 63022, CIP No. 58-004 ANNUAL ALLOCATION - MISCELLANEOUS REQUIREMENTS - CITY STREETS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$72,200 (\$67,200 from Fund 30245 and \$5,000 from Fund 63022 Mrs. Barbara Houlton cost ) from CIP No. 58-004 ANNUAL ALLOCATION - MISCELLANEOUS REQUIREMENTS - CITY STREETS, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to Mrs. Barbara Houlton.
