BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for IMPROVEMENT OF PUMP STATION NO. 47.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized, if circumstance warrant, to finance or refinance this project with tax exempt securities.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$264,900 from Sewer Revenue Fund 41506, Construction Outlay 70492, CIP No. 46-106.6 ANNUAL ALLOCATION - PUMP STATION RESTORATIONS is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
