RESOLUTION NUMBER R- 274635

ADOPTED ON OCT 30 1989

WHEREAS, in 1987, United Way identified AIDS as one of its key government relations issues, and has been actively involved in community problem solving joint efforts with other public and private organizations; and

WHEREAS, United Way, in partnership with the San Diego Community Healthcare Alliance, has recently granted \$23,000 in Board Discretionary Grant funds to (1) conduct a Needs Assessment Survey for Persons with HIV Infection in San Diego County; (2) provide Management Audits to AIDS-related agencies to help them assess their management strengths and weaknesses; and (3) make funds available to meet some of the management needs identified in the audits; and

WHEREAS, more than \$150,000 in 1988 United Way campaign funds were designated by the donor to local AIDS-related agencies, United Way is behind most other United Ways in large metropolitan areas in terms of funding through the citizen review process for programs specifically targeted at AIDS services; and

WHEREAS, United Way has issued Preliminary Priorities for 1990-92 which include identifying funding for client services in the Community Problem Area for AIDS in the next Priority Grant funding cycle in 1991; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that as part of The City of San Diego's overall efforts to encourage

the citizens of San Diego to become more involved in addressing the AIDS crisis in our community, that this Council, for and on behalf of all the people of San Diego, strongly supports the United Way's preliminary priorities recommendation that AIDS be identified as a Community Problem Area eligible for funding in the next Priority Grant cycle.

BE IT FURTHER RESOLVED, that should insufficient funds be available to fund all the recommended priority grant areas, that AIDS be among those areas selected for funding.

BE IT FURTHER RESOLVED, that the United Way be commended and encouraged to continue its community problem solving efforts in the area of AIDS and that the United Way also be encouraged to explore all possible avenues for making funding available for AIDS service agencies prior to the next Priority Grant cycle through either its own resources or, by virtue of its position as a leader in the nonprofit sector, encouraging others to become involved or increasing their support of these agencies.
