

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$130,000.00, made payable to Muth Leang, Chhoeun Khiev and Rattanac Leang, a minor and their attorney of record David Korrey in full settlement of the lawsuit and of all claims.
