

RESOLUTION NUMBER R-274646

ADOPTED ON OCTOBER 30, 1989

BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby approves the recommendations contained in City Manager's Report No. 89-507 regarding the Balboa Park House of Charm, and directs the City Manager to implement the recommendations accordingly, subject to the following:

1. That the Public Facilities and Recreation Committee shall review and oversee the implementation of the City Manager's recommendations governing tenancy in the House of Charm;

2. That the Hall of Champions shall have 180 days from the date of the adoption of this resolution in order to determine whether the Federal Building shall suit their needs and, if so, that the building then be made available to them as an exclusive tenant. If, however, the Hall of Champions shall determine that the Federal Building is not suitable for their purposes, then such space shall instead be made available to the Mingei International Museum.

3. That the Mingei International Museum may move into the Casa de Balboa into the space that would be vacated by the Hall of Champions should the Hall of Champions elect tenancy in the Federal Building;

4. That the City Manager shall refer back to the Public Facilities and Recreation Committee the question of the resolution of the Museum of Photographic Arts space expansion.


