APPROVING MAP OF SOLEDAD HILLS.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Lawrence E. Cole, Licensed Land Surveyor, entitled "SOLEDAD HILLS being a subdivision of a Portion of the Northwest Quarter of Pueblo Lot 1785 of the Pueblo Lands of San Diego in the City of San Diego, County of San Diego, State of California, according to the map thereof made by James Pascoe in 1870, a copy of which said map was filed in the Office of the County Recorder of San Diego County November 14, 1921 and is known as miscellaneous Map No. 36," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Ocean Breeze Court and a Portion of Alta Vista Street, and said street and portion of street are hereby declared to be a public street and a portion of public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easement with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on the map within the subdivision.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street and portion of a street are accepted on behalf of the public as heretofore stated; together with the easement with the right of ingress and egress for the construction and maintenance of drainage facilities, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
