BE IT RESOLVED, by the Council of the City of San Diego that all bids theretofore received on August 17, 1989, pursuant to publication of notice calling for bids on COLLIER COMMUNITY PARK COMFORT STATION are hereby rejected.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for COLLIER COMMUNITY PARK COMFORT STATION.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized, if circumstances warrant, to finance or refinance this project with tax exempt securities.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$58,000 (\$7,864 from PSD Fund 11560 and \$50,136 from PSD Fund No. 17000 to supplement funds previously authorized by Resolution No. 274034, adopted on August 17, 1989, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
