WHEREAS, Resolution No. R-274659 (R-90-581) came before the San Diego City Council on October 31, 1989, awarding a contract to TRI-CORE CONSTRUCTION COMPANY for STANDLEY COMMUNITY PARK ADDITIONAL IMPROVEMENTS; and

WHEREAS, use of deductive alternatives would have been necessary to award the contract with the funds then available, therefore said resolution called for utilization of deductive alternatives 1 through 4 and authorized the expenditure of \$15,700 to supplement funds previously approved for said project; and

WHEREAS, McKellar Development of La Jolla and Ahmanson Developments, Inc. have contributed \$42,000 in order that the completion of Standley Park Improvements may proceed without the necessity of utilizing deductive alternatives, and

WHEREAS, such \$42,000 was deposited with the Treasurer of The City of San Diego and placed in fund 79150, for the sole and exclusive purpose of funding the Standley Park improvements; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the low base bid of \$171,800 by TRI-CORE CONSTRUCTION, a sole owner, meeting specifications for STANDLEY COMMUNITY PARK ADDITIONAL IMPROVEMENTS, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to

execute a contract therefore in accordance with the form on file in the office of the City Clerk as Document No. 118896.

BE IT FURTHER RESOLVED, that the expenditure of \$57,700 (\$15,700 from PSD Fund No. 13000 to supplement funds previously authorized by Resolution No. R-272854, adopted on February 13, 1989; and \$42,000 contributed by McKellar Development and Ahmanson Developments, Inc. from fund 79150, for the sole and exclusive purpose of funding the Standley Park improvements), is hereby authorized solely and exclusively for said project and related costs and the Auditor and Comptroller is authorized upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that the City Council for the citizens of San Diego express their gratitude to McKellar Development and Ahmanson Developments, Inc. for their generous gift to complete the improvements of Standley Park.
