ADOPTED ON OCT 31 1989

WHEREAS, graffiti is used to mark the territory of gangs and, in turn, designates areas of high drug and crime activity; and

WHEREAS, the citizens of the Mid-City are dedicated to protecting the quality of their neighborhood by painting out all graffiti in the area; and

WHEREAS, the Mid-City make-over will go a long way toward curtailing these activities; and

WHEREAS, countless hours of hard work have gone into organizing this event and the Mid-City Chamber of Commerce has selflessly led a dedicated group of volunteers who are committed to cleaning up the Mid-City; and

WHEREAS, benefactors such as Universal Paints of Santee, McKellar Development of La Jolla, San Diego Gas and Electric, The El Cajon Boulevard Business Association, the Adams Avenue Business Association, Frazee Paints, the Coca Cola Bottling Company of San Diego, Cox Cable, Pacific Bell, have generously made financial and in-kind contributions to make this project successful; and

WHEREAS, over 1,200 gallons of paint have been donated and more than 1,000 volunteers are expected to participate, including over 500 university students and school children; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Saturday, November 4, 1989 be declared s "Mid-City Make-over Day" in The City of San Diego.

BE IT FURTHER RESOLVED, that all San Diegans are urged to support this monumental graffiti paint-out and support all group cleanup efforts throughout the City.
