BE IT RESOLVED, by the Council of The City of San Diego, that it hereby confirms the costs of weed abatement, as shown on the Report of the Fire Chief, a copy of which is on file in the office of the City Clerk as Document No. RR- $\frac{27468}{}$, against the following properties and in the amounts listed next to each parcel number:
