He suggested repairing damaged concrete benches in Mission Bay restrooms with cement block caps instead of patching. Although savings are difficult to identify this was considered to be a significant operational improvement.
Sharon Smith	Purchasing	\$ 80	Ms. Smith was a Word Processing Operator in Purchasing when she submitted the suggestion to include modification guidelines in the Liaison's Manual to expedite processing time for purchase orders. Although savings are difficult to identify this was considered to be a significant operational improvement.
Minerva Schwab Sylvia Taylor	Risk Management	\$ 80	Ms. Schwab and Ms. Taylor are Claims Clerks in Risk Management. They suggested combining information on the Workers' Compensation Worksheet to eliminate the use of two additional information forms. Although savings are difficult to identify this was considered to be a significant operational improvement.
