WHEREAS, the Catholic Worker movement in San Diego began with a meal on November 14, 1979 in the parking lot of Episcopal Community Services with twenty volunteers serving food cooked at Christ the King Church; and

WHEREAS, over the next ten years with permanent places for serving and not so permanent places for cooking, the volunteers prepared meals for the needy and the hungry, rain or shine; and

WHEREAS, the goods they received from the many businesses in San Diego helped them, and in order to get the meals ready, the volunteers often not only transported the food but cleaned the produce and prepared the dinners in difficult places; and

WHEREAS, with dedication and determination, the Catholic Worker volunteers have, over the years, made sure that balanced meals were served to the homeless, the needy and the hungry; and

WHEREAS, their love for their service, and their kindness to those who have come before them, meal after meal is exemplary;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby proclaims November 14, 1989 to be "CATHOLIC WORKER DAY" in
