WHEREAS, The City of San Diego, a municipal corporation, is the owner of a parcel of land in The City of San Diego, County of San Diego, State of California, being a subdivision of a Portion of Parcel 2 of Parcel Map No. 8547, according to map thereof filed in the Office of the County Recorder of San Diego County, March 19, 1979; Portions of Parcels 9, 10 and 12 of Parcel Map No. 14737, in the City of San Diego, County of San Diego, State of California, according to map thereof filed in the Office of the County Recorder of San Diego County, March 20, 1987, together with Portions of Portobelo Drive and Via Valarta as dedicated to public use, and together with Via Valarta as closed and vacated to public use pursuant to the provisions of Section 66499.20 1/2 of the Subdivision Map Act; and

WHEREAS, said City proposes to file a subdivision map of said area to be known as TIERRASANTA NORTE V UNIT NO. 2; and

WHEREAS, the Planning Commission of The City of San Diego has approved the final map of TIERRASANTA NORTE V UNIT NO. 2 and has recommended to the City Council approval of said map; and


