RR 274737-1 and RR 274737-2, granting to said City easements for street and drainage purposes in a portion of Lot 2 of Prod Subdivision, Map No. 7215, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for street purposes is hereby dedicated as and for a public street, and the same is hereby named EUCLID AVENUE.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
