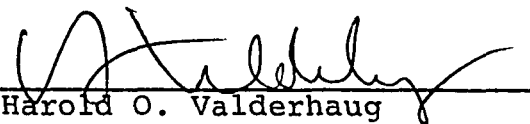
RESOLUTION NUMBER R- 274738

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of street easement deeds of MCDONALD'S CORPORATION, a Delaware Corporation, bearing date of September 8, 1989; CHEVRON U.S.A., INC., a Pennsylvania corporation, bearing date of July 14, 1989; OTAY OFFICE INVESTORS, LTD., a California limited partnership, bearing date of July 13, 1989; and OTAY INTERNATIONAL CENTER, a general partnership, bearing date of July 14, 1989; all executed in favor of The City of San Diego, copies of which deeds are on file in the office of the City Clerk as Document Nos. RR- 274738-1, RR- 274738-2, RR- 274738-3 and RR- 274738-4, granting to said City easements for public street purposes in portions of Lots 1, 13, 14 and 19 of Otay International Center Lot No. 5, Map 11897, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named SIEMPRE VIVA ROAD.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
