ADOPTED ON NOV 20 1989

WHEREAS, the City's third five-year Equal Employment Opportunity Program, adopted by the City Council on January 25, 1985, assigns the Personnel Director the responsibility for preparing periodic reports on the City's progress in meeting Equal Opportunity hiring goals; and

WHEREAS, during the period December 15, 1988 to June 9, 1989, there was a net increase of 93 women and 138 minorities in the City's work force; and

WHEREAS, women now comprise 33.2% of the City's work force and minorities 36.4%; and

WHEREAS, during this reporting period, thirty placements of persons with disabilities were made pursuant to the City-wide opportunity goal to hire handicapped individuals; and

WHEREAS, during this period, increases found in the number of women employed by The City of San Diego reflect hiring in the managers/administrators, professional/technical, clerical, fire professionals, police officers and service workers categories and increases in the number of minorities are found in the occupational categories of professional/technical, clerical, crafts, fire professionals, police officers; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby accepts the Personnel Director's second Equal Employment Opportunity Report for the period December 15, 1988 to June 9, 1989.
