
ADOPTED ON NOV 20 1989

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a sole source negotiated contract with the I LOVE A CLEAN SAN DIEGO COUNTY, INC., for recycling information and education services in support of the City's Recycling and Waste Reduction Plan 1988-1992, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 274753 , together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$110,000 from Fund No. 41200, is hereby authorized, solely and exclusively for the purpose of providing funds for the above services.
