

RESOLUTION NUMBER R-274758

ADOPTED ON NOVEMBER 20, 1989

WHEREAS, Councilmember Henderson requested a position be authorized and added to his budget to serve as a Community Outreach Coordinator for Mission Bay; and

WHEREAS, the request indicated the position was to be in the unclassified service of The City of San Diego and would require an addition of \$25,000 to the budget for District 6; and

WHEREAS, the Charter requires such actions as exempting personnel from the classified service to first be reviewed and commented upon by the Civil Service Commission; and

WHEREAS, that action is required by Charter section 117 and must be completed and it is planned to do so; and

WHEREAS, this will also require an amendment to the annual salary ordinance to create such new classification; and

WHEREAS, the present action requests approval of the concept and would direct the City Manager to identify a source of funding for such position; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the request for providing a position in the budget of Council District 6 to act as a Community Outreach Coordinator for the Mission Bay Master Plan Update, be and the same is hereby approved.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby directed to transfer within the General Fund

100, the sum of \$25,000 from the Unallocated Reserve (605) to the Council District 6 (026) budget for related personnel and nonpersonnel services for the balance of fiscal year 1990.

BE IT FURTHER RESOLVED, that the City Attorney is requested to prepare the necessary amendatory ordinances to create said unclassified position after review by the Civil Service Commission.
