WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of streets and public service easements by City Council resolution where the portion of street to be vacated is excess to the City's right-of-way needs and is no longer required for street or highway purposes; and

WHEREAS, the abutting property owners have requested the vacation of the excess portion of Pomerado Road in connection with Pomerado Estates (TM 88-1273) to facilitate development of their property; and

WHEREAS, the portion of street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the excess portion of Pomerado Road, as more particularly shown on Drawing No. 17451-D, and on file in the office of the City Clerk as Document No. RR- 274764-/, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.
- 2. The the resolution shall not become effective unless and until the final map for Pomerado Estates (TM 88-1273) has been approved by Council action. In the event that the final map is not approved within six (6) years after adoption of this resolution, this resolution shall become void and be of no further force or effect.
- 3. That the City Engineer shall advise the City Clerk of the completion of the aforementioned final map, and the City Clerk shall then cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.




