
APPROVING AMENDMENTS TO THE GASLAMP QUARTER

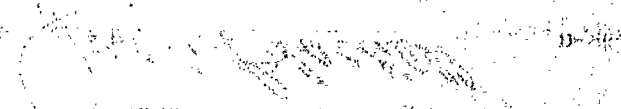
