RESOLUTION NUMBER R- 274782

ADOPTED ON NOV 21 1989

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on October 22, 1987, to consider the proposed amendment to the MIRA MESA COMMUNITY PLAN (NO. 86-0613) affecting the property east and west of Black Mountain Road and north of Galvin Avenue for the purpose of:

1. Redesignating an 84.5-acre site from commercial recreation, low (5-9 du/ac) and low-medium (10-15 du/ac) density residential to medium-low (16-29 du/ac) density residential;

2. Reclassifying Black Mountain Road from a four-lane major to a six-lane primary arterial between Galvin Avenue and the Los Penasquitos Canyon bridge; and

3. Reclassifying Capricorn Way from a four-lane major to a four-lane collector between Westview Parkway and the western boundary of the subject property; and

WHEREAS, the Planning Commission approved and recommended adoption by the City Council of said amendment; and

WHEREAS, the Council of The City of San Diego having considered all maps, exhibits, written documents and materials in this matter, having heard all oral presentations given, and being fully advised concerning the same at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby approves the amendment of the MIRA MESA COMMUNITY PLAN (NO. 86-0613), a copy of which is on file in the office of the City Clerk as Document No. RR- 274782.
