WHEREAS, the Council of The City of San Diego has charged the Centre City San Diego Planning Committee with the responsibility of recommending a revision to the 1976 Community Plan for Centre City, San Diego; and

WHEREAS, a principal element in the Centre City San Diego
Planning Committee's work has focused on developing a plan which
emphasizes a number of major activity centers in various
locations throughout Centre City; and

WHEREAS, the location of these activities is enhanced considerably if they reinforce existing or planned light rail connections and occur along recognized transportation corridors; and

WHEREAS, these type of facilities should be located and designed so as to offer minimum on-site parking and if possible provide the potential for shared parking when not at peak use; and

WHEREAS, the Centre City San Diego Planning Committee has recognized the importance of attracting one of a kind facilities to those activity areas such as a sports arena; and

WHEREAS, the Centre City San Diego Planning Committee has endorsed the desirability of locating a sports arena facility within the Centre City area referred to as "Centre City East"; and

WHEREAS, the San Diego Arena Corp., and its subsidiary San Diego Entertainment, Inc., has expressed an interest in developing a sports arena facility within the area referred to as "Centre City East"; and

WHEREAS, a project of this magnitude will require extensive private commitment and investment, and the encouragement and approval of the Council of The City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council supports the proposal of the San Diego Arena Corp. and its subsidiary San Diego Entertainment, Inc., to continue plans to develop a sports arena facility within the area referred to as "Centre City East."
