BE IT FURTHER RESOLVED, that the City Manager is hereby authorized, if circumstances warrant, to finance or refinance this project with tax exempt securities.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$680,000 (\$41,100 from Capital Outlay Sales Tax Fund 30245 and \$638,900 from Proposition "A" Fund 30300) from CIP No. 52-295 GENESEE AVENUE - LINDA VISTA TO OSLER STREET, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
