BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF BARRIO YOUTH CENTER PARKING LOT.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$79,000 from Community Development Block Grant Fund 18523/5633/3301 CIP No. 37-195 BARRIO YOUTH CENTER - PARKING LOT is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
