RESOLUTION NUMBER R- 274827

ADOPTED ON DEC 05 1989

WHEREAS, the provisions of Council Policy No. 600-15 require that a noticed public hearing be conducted before the City Council prior to the vacation of a City street; and

WHEREAS, the vacation of Mission Valley Court northwest of Mission Valley Road has been initiated by the submission of a tentative map; and

WHEREAS, Section 66499.20½ of the California Government Code provides that the filing of the map shall constitute abandonment of all streets and easements not shown on said map; and

WHEREAS, the proposed Tentative Parcel Map (TM 89-0844) contains Mission Valley Court, which is right-of-way no longer required for street purposes; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That Mission Valley Court northwest of Mission Valley Road, within the Tentative Parcel Map (TM 89-0844) boundaries, as more particularly shown on the attached Exhibit "A," which is by this reference incorporated herein and made a part hereof, be, and the same is hereby authorized to be, vacated as provided under Section 66499.20½ of the California Government Code.

2. That the resolution shall not become effective unless and until the Final Parcel Map for TM 89-0844 has been approved by Council action. In the event that the Final Parcel Map is not

approved within six years after adoption of this resolution, this resolution will become void and be of no further force or effect.

3. That the City Engineer shall advise the City Clerk of the completion of the aforementioned parcel map, and that the City Clerk shall then cause a certified copy of this resolution, with Exhibit "A," attested to him under seal, to be recorded in the Office of the County Recorder.
