A RESOLUTION DECLARING THE RESULTS OF THE

WHEREAS, a general municipal election was held in the City of San Diego, on Tuesday, November 7, 1989, pursuant to the provisions of Ordinance No. O-17332 (New Series) (adopted on July 31, 1989), for the purpose of electing candidates; and

WHEREAS, a copy of the certificate of the Registrar of Voters of San Diego County canvassing the returns of the general municipal election, as certified to the City Clerk, has been duly received; and

WHEREAS, a canvass of these elections has been completed and the City Clerk has certified the results to the City Council;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council finds and determines pursuant to the provisions of Section 27.2206 of the San Diego Municipal Code, as follows:

I

The whole number of votes cast in the City was 82,773.

II

The total vote received by each municipal candidate at the general municipal election is as follows:

A. FOR COUNCIL DISTRICT NO. 1 (four-year term):

ABBE WOLFSHEIMER 16,231

BOB TRETTIN 15,613

ABBE WOLFSHEIMER having received a majority of all votes cast is hereby declared elected to the office of Council District No. 1.

B. FOR COUNCIL DISTRICT NO. 5 (four-year term):

LINDA BERNHARDT 13,832

ED STRUIKSMA 9,179

LINDA BERNHARDT having received a majority of all votes cast is hereby declared elected to the office of Council District No. 5.

III

The number of votes in each precinct cast for each person is recorded in the Election Returns Book, which book is a part of the records of this Council.

The City Clerk shall make public the results of the canvass of the general municipal election by publication of a copy of this resolution.
