1. That the City Manager be and he is hereby authorized and directed to execute, for and on behalf of THE CITY OF SAN DIEGO, an Amendment to Subdivision Improvement Agreement for SUNBURST SCRIPPS UNIT 2, on file in the office of the City Clerk as Document No. RR- 274836, to provide for the substitution of BPKC/GADCo I, a California general partnership for Sunburst Homes Company, as subdivider.

2. That the Rider issued by Insurance Company of the West, in the amount of \$1,333,390 is hereby accepted to substitute BPKC/GADCo I, a California general partnership, for Sunburst Homes Company as principal on the surety for the required improvements in the subdivision, and attached to Exhibit C to the aforesaid agreement.
