WHEREAS, DUNFEE PROPERTIES, a California corporation, and SORRENTO MESA ASSOCIATES, a California general partnership, have requested an exchange of drainage easements; and

WHEREAS, the easement to be acquired is being granted on proposed Parcel Map T.M. No. 89-0053; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No.

RR-274838, quitclaiming to DUNFEE PROPERTIES and SORRENTO MESA ASSOCIATES all of the City's right, title and interest in the drainage easement in Lots 2 and 3 of Lusk Mira Mesa Business Park East I, Unit I, Map 11024, as more particularly described in the quitclaim deed.

2. That the City Clerk is hereby authorized and directed to cause the quitclaim deed, and a certified copy of this

resolution, attested by him under seal, to be recorded in the  
office of the County Recorder.
