Robert Tobias	Utilities	\$ 320	Mr. Tobias is a Waste Water Plant Operator with the Metro Division. He suggested the installation of a walkway with handrails adjacent to the manifold valves. Although savings are difficult to identify, this is considered to be a significant safety improvement.
Lillian Stewart	Risk Management	\$ 90	Ms. Stewart is a Rehabilitation Coordinator in the Risk Management Department. She suggested the use of an out card system for the Workers' Compensation Division. Although savings are difficult to identify, this is considered to be a significant operational improvement.
Christine Davis	Library	\$ 80	Ms. Davis is a Clerk with the Extension Division. She suggested that library patrons be notified when their book order suggestions are filled. Although savings are difficult to identify, this is considered to be a significant operational improvement.
Tony Padilla	Utilities	\$ 45	Mr. Padilla is an Equipment Technician II with the Production Division. He suggested the installation of plexiglass walls around the ferric-chloride caustic-sulfuric acid tanks at Aqua II. This is an additional award based upon a re-evaluation. Although savings are difficult to identify, this is considered to be a significant safety improvements.
