WHEREAS, City Manager Report No. 89-469 establishes that it is common practice for most major golf courses to waive fees and allow complimentary rounds of play for golf course professionals, golf course employees and pro shop employees, and, on occasion, for other players with greenskeeping experience, on the grounds that such waiver allows for golf course evaluation and necessary preparation for the repair thereof; and

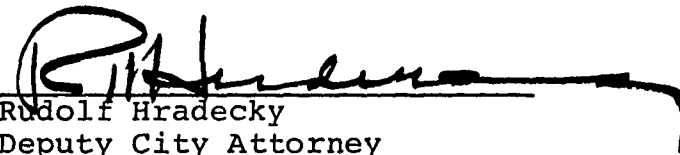
WHEREAS, the waiver of such fees serves a public purpose by allowing the Torrey Pines and Balboa Park golf courses to be maintained according to professional play standards and recommendations; and

WHEREAS, City Manager Report No. 89-469 establishes that City Council approval for a fee waiver is appropriate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby approves City Manager Report No. 89-469, a copy of which is on file in the office of the City Clerk as Document No. RR- 274846, and authorizes the City Manager and the City Auditor and Comptroller to waive or allow the waiver of fees for the categories of players listed in said City Manager's Report, provided that written course evaluations are

submitted by each individual for whom the complimentary round is hereby authorized.
