ADOPTED ON DEC 11 1989

WHEREAS, the City Council wishes to strengthen its code enforcement efforts by using additional enforcement tools; and

WHEREAS, the City Council is authorizing an amendment to the Municipal Code to authorize the issuance of administrative citations as an additional remedy for the enforcement of Municipal Code regulations relating to minor violations; and

WHEREAS, the City Council is also authorizing an amendment to the Municipal Code to authorize zoning inspectors to issue parking citations to enforce certain zoning regulations: NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Planning Director be authorized to implement a code enforcement program which utilizes both administrative and parking citations as enforcement methods for certain types of violations.

BE IT FURTHER RESOLVED, that the City Manager and Planning Director are directed to monitor and evaluate the use of these enforcement tools and report back to the Transportation and Land

Use Committee regarding their effectiveness at the end of one year of implementation.
