RESOLUTION NUMBER R- 274860

ADOPTED ON DEC 11 1989

WHEREAS, on July 11, 1989 pursuant to Resolution No. R-273966, the Council of The City of San Diego declared certain parcels of land within the city to be public nuisances due to hazards caused by their weed and rubbish accumulation; and

WHEREAS, the Council authorized weed abatement of said parcels by the Fire Chief, with the cost to be borne by the City and assessed as a lien against the properties; and

WHEREAS, the Fire Chief has abated the public nuisances on the parcels of land designated in the report of the Fire Chief, and full compliance with the procedures set forth in San Diego Municipal Code sections 54.0201 through 54.0206 has been accomplished; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby confirms the costs of weed abatement, as shown on the Report of the Fire Chief, a copy of which is on file in the office of the City Clerk as Document No. RR-274668, against the following properties and in the amounts listed next to each parcel number:



BE IT FURTHER RESOLVED, that the Fire Chief is authorized to bill the affected property owners for the costs of weed abatement to the City.

BE IT FURTHER RESOLVED, that the City Clerk is directed, on or before August 10, 1990, to forward a copy of this resolution, together with a copy of the Report of the Fire Chief, to the Office of the County Recorder for filing as a lien against each affected parcel, and a copy to the Office of the County Auditor for recording on the assessment roll for each affected parcel.
