WHEREAS, Committee was created for the purpose of monitoring and coordinating the City Council's implementation of and provide accountability for the recommendations of the Mayor's Committee Against Drug Abuse; and

WHEREAS, it is desired to continue the existence of Committee through June 1990 to meet the request of the Mayor and City Manager to develop a five-year plan for combatting drug abuse in San Diego; and

WHEREAS, it is necessary to remove Suzanne Dixon, M.D., Mr. Jack Merker, and Mr. Doug Wilkerson from Committee membership because they are unable to participate in Committee activities due to professional demands; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Mayor's and City Manager's recommendation for continuing the existence of Committee through June 1990, is approved.

BE IT FURTHER RESOLVED, that Suzanne Dixon, M.D., Mr. Jack Merker, and Mr. Doug Wilkerson are hereby removed from Committee membership and the following appointments by the Mayor of The City of San Diego to serve as members of the San Diego Substance

Abuse Committee (SANDSAC) Committee, pursuant to section 43(b) of
the City Charter, be and the same are hereby confirmed:
