No. 90-245.0, Capital Outlay Fund Unallocated Reserve, Capital Outlay Sales Tax Fund 30245, for the acquisition of real property and related costs for the parking lot.

BE IT FURTHER RESOLVED, that the City Manager is authorized to accept a standard form grant deed for the above-described property.
