BE IT RESOLVED, by the Council of the City of San Diego that the City Auditor and Comptroller is hereby authorized to expend an amount not to exceed \$530,000 from C.I.P. No. 35-057.0, FLORENCE RIFORD LIBRARY CENTER (LA JOLLA), consisting of \$199,000 from Capital Outlay Fund 302453 and a \$225,000 cash gift from Florence Riford (contingent upon receipt of funds), pledged in an agreement signed by Mrs. Riford on May 4, 1988 and accepted by Resolution R-271427 on July 20, 1988, and \$106,000 transferred from C.I.P. No. 90-245.0, Capital Outlay Fund Unallocated Reserve, Capital Outlay Sales Tax Fund 30245, for the acquisition of real property and related costs for the parking lot.

BE IT FURTHER RESOLVED, that the City Manager is authorized to accept a standard form grant deed for the above-described property.
