WHEREAS, for the past several years, the Stadium Authority
Board has expressed concern over the appearance of the back of
the scoreboard at San Diego Jack Murphy Stadium (the "Stadium");
and

WHEREAS, the cost of painting a mural on the back of the Stadium's scoreboard would range from between thirty thousand dollars (\$30,000) and fifty thousand (\$50,000) and is not a high priority in The City of San Diego's capital improvement plan for the Stadium; and

WHEREAS, in light of the above, John Carlson, a member of the Stadium Authority Board, has generously offered to donate the funds necessary for the costs of painting a mural on the back of the Stadium's scoreboard, said gift including having the mural designed and completed by Mario Uribe, a local artist; and

WHEREAS, Mr. Uribe's design concept for the mural is attached to City Manager Report No. 89-571, on file in the Office of the City Clerk; and

WHEREAS, given Mr. Carlson's donation, The City of San Diego will only have to pay approximately three thousand dollars (\$3,000) in labor and material costs for the mural; NOW, THEREFORE,

BE IT RESOLVED, by the Council for The City of San Diego, that it hereby accepts Mr. John Carlson's generous donation to

pay for the costs of painting the mural on the back of the scoreboard at San Diego Jack Murphy Stadium, the mural being described more fully in City Manager Report No. 89-57/, subject to review of the proposed work by a joint committee of members of the Stadium Authority Board and the Commission of Arts and Culture.
