

BE IT RESOLVED, by the Council of The City of San Diego that the low bid of ED GOMEZ & SON, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing LANDSCAPE MAINTENANCE OF TWENTY-SIX (26) LIBRARY SITES as may be required for a period of one (1) year beginning January 1, 1990 through December 31, 1990 at a cost of \$4,401.36 per month and an estimated 250 hours of extraordinary service at \$14.00 per hour for a total estimated annual cost of \$56,316.33. Terms are net 30 days with options to renew the contract for four (4) additional one year periods, with price escalation not to exceed 10% of prices in effect at the end of each prior year.

BE IT FURTHER RESOLVED that in the event the contractor fails to perform in accordance with the specifications, the Purchasing Agent is hereby authorized to terminate the contract and reaward to the next low bidder, and, if necessary, to successive low bidders until a bidder is found who does comply with the specifications.
