RESOLUTION NUMBER R-275053

ADOPTED ON OCTOBER 31, 1989

WHEREAS, under Resolution No. R-274001, the City Council adopted on July 17, 1989 a minimum water capacity charge of one thousand six hundred and fifty-one dollars (\$1,651.00) and a minimum sewer capacity charge of three thousand two hundred and thirty-five dollars (\$3,235.00) per single family dwelling or its equivalent pursuant to San Diego Municipal Code sections 67.72 and 64.0410; and

WHEREAS, said resolution exempted designated redevelopment areas; and

WHEREAS, upon further reflection and review of said item, it was not the intent of the Council to provide any exemption but rather have the Public Services and Safety Committee review and evaluate exemptions and make recommendations to the Council; and

WHEREAS, the clarification of Resolution No. R-274241 as to the issue of applicability of minimum water and sewer capacity charges in designated redevelopment areas was properly renoticed pursuant to Section 64.0410; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the minimum water and sewer capacity charge established by Resolution No. R-274001 is applicable to all areas of the City.

BE IT FURTHER RESOLVED, that the Public Services and Safety Committee is hereby requested to review and recommend, if appropriate, an exemption or exemption criteria to the above minimum capacity charges.

BE IT FURTHER RESOLVED, that consistent with Resolution No. R-274241 the applicability of the above-referenced minimum sewer capacity charges in designated redevelopment areas shall be effective sixty (60) days following passage of this resolution.
