WHEREAS, Adventure 16 will once again sponsor the annual cleanup on Saturday, June 2, 1990; and


WHEREAS, this cleanup will include litter removal along Father Junipero Serra Trail, removal of non-native plants, and graffiti removal; and

WHEREAS, for the safety of the volunteers, Father Junipero Serra Trail should be closed to motor vehicle traffic; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby directed to close Father Junipero Serra Trail to vehicular traffic from sunset June 1, 1990 to 5:00 p.m. June 2, 1990, for the purpose of increasing safety for Adventure 16 volunteers participating in the annual park cleanup.
