

WHEREAS, Consultant agrees to provide police officers for DARE presentations to students and District agrees to pay consultant the sum of two hundred thousand dollars (\$200,000.00) for such services; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement between The City of San Diego and District to provide police officers for the DARE program, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 276053.
