AN ORDINANCE INCORPORATING AN 0.23± ACRE SITE, LOCATED AT THE SOUTHWEST CORNER OF THE INTERSECTION OF BORDER VILLAGE ROAD AND VIRGINIA AVENUE IN THE CO ZONE, AND WITHIN THE SAN YSIDRO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM CO TO CV ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0426.1, AND REPEALING ORDINANCE NO. 8028 (NEW SERIES), ADOPTED DECEMBER 18, 1958 OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a 0.23 acre site, located at the southwest corner of the intersection of Border Village Road and Virginia Avenue in the CO Zone, and within the San Ysidro Community Plan area, in the City of San Diego, California, within the boundary of the district designated "CV" on Zone Map Drawing No. B-3921, filed in the office of the City Clerk as Document No. 0017412, be, and it is hereby incorporated into CV Zone, as such zone is described and defined by San Diego Municipal Code Section 101.0426.1.

Section 2. That Ordinance No. 8028 (New Series), adopted December 18, 1958, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this

ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
